#### **SCHUFA-note on rental agreements**

For the purpose of checking the creditworthiness of the prospective tenant before the conclusion of the rental contract, RHEINBAU GmbH transmits personal data collected within the scope of this contractual relationship about the application for this rental relationship as well as data about non-contractual or fraudulent behavior to SCHUFA Holding AG, Kormoranweg 5, 65201 Wiesbaden.

The legal basis for these transfers is Article 6 Paragraph 1 Letter b and Article 6 Paragraph 1 Letter f of the General Data Protection Regulation (GDPR). Transmissions on the basis of Article 6 paragraph 1 letter f GDPR may only take place if this is necessary to protect the legitimate interests of RHEINBAU or third parties and does not outweigh the interests or fundamental rights and freedoms of the person concerned, which require the protection of personal data.

SCHUFA processes data and also uses it for the purpose of profiling (scoring) to provide its contractual partners in the European Economic Area and Switzerland and possibly other third countries (if the European Commission has issued an adequacy decision) with information, among other things, to assess the creditworthiness of to give to natural persons.
